Pace of online activities: This course is divided into **three modules** that are released at the beginning of the semester. Each section has a deadline to prevent you from waiting until the end of the semester to complete the entire course. However, you are welcome to work ahead as you like. I encourage you to complete the assignments throughout the section rather than waiting to do all of them at the due date.

Credit hours and work expectations: This is a **2-credit-hour course**. According to [Ohio State policy](#), students should expect around 2 hours per week of time spent on direct instruction (instructor content and Carmen activities, for example) in addition to 6 hours of homework (reading and assignment preparation, for example) to receive a grade of (C) average.

Prerequisites: There are no prerequisite courses needed, though basic biology and chemistry understanding will help.

Additional Required Materials:

You will need to have access to a kitchen and basic utensils. You will be expected to purchase and prepare some food for activities in this course. This is a minimum list, you may choose to use more:

- Oil
- Ground spice like cinnamon or cloves
- 4 eggs

- 3 cups of flour
- 1 packet Kool-aid (though regular unsweetened tea or coffee can be used as an alternative)
- 2 cups plus 3 tablespoons sugar
- 3 tablespoons or 3 packets of 2 other sweeteners
- 1 cup or 2 sticks of butter or margarine
- 1 teaspoon of vanilla
- ½ cup corn starch
- 1 teaspoon salt
- 3 cans of three different foods (selected from the list in “The heat is on” assignment)
- Food/recipe of your choice – enough to cook 3 times.

Equipment and Supplies needed: Again, this is a minimum list, you may choose to use more.

- Access to a sink with soap
- Other cleaning supplies for your workspace
- 3 cups
- Pitcher or other vessel large enough to hold 2 quarts of liquid
- Mixing spoon/spatula
- At least 1 bowl and 2 plates, or 3 medium bowls
- Whisk or fork, but an electric mixer will work easier if possible
- Measuring spoons and cups
- Medium sized cooking pot
- Oven
- Stove top
- Baking pan
- Food thermometer
- Nail and hammer or some other method to puncture cans
- Equipment and utensils needed to prepare and cook food of your choice with 3 methods

Course Description:

This course will introduce you to sanitation rules, basic culinary/baking methods, fundamentals of cooking & the science behind its methodology. I hope to provide you an understanding of common foods & their function in cooking. This class will include activities designed to explain the science behind preparing safe, quality food.

Goals:

Successful students will be able to identify risky situations and foods to prevent food borne illnesses, understand the function of common food components and ingredients, and be able to predict the outcome of ingredient substitutions or various cooking methods.

Learning Outcomes:

By the end of this course, students should successfully be able to:

1. Clean and sanitize food prep surfaces and equipment and handle food in a manner to prevent food borne illnesses.
2. Understand the function of common food ingredients
3. Predict the outcome of simple substitutions of ingredients or preparation methods.

Instructor’s policy on late or make work:

Due dates for assignments will be Wednesdays at 5:00 pm (Columbus time) unless otherwise noted. **ALL** assignments must be submitted through Canvas. Unless there is an unforeseen catastrophe with the system, I will not accept any work through email. **It is your responsibility to make sure your assignment is submitted properly.**

The Canvas system is set to assign a 0 at the deadline for anyone that has not submitted. If you submit your assignment after the deadline there will be a 25% penalty assessed and that will compound for each

subsequent 24 hours late. At 72 hours past the deadline the penalty is 100% so past that point **no late work will be accepted.**

Only emergencies will be considered on an individual basis - hospitalization, or death in the family are good examples. Travel for work or school, and your common cold will not be excused. **Documentation of the emergency will need to be presented for consideration of accepting late work.**

Evaluation:

[Syllabus Quiz](#) is simply a tool I use to keep you honest about reading the syllabus. You must score at least a 20/25 or 80% for the course material to open.

[So clean you could eat off the...](#) In this assignment you will either take pictures in your own kitchen (or your Res hall) or find them online, then identify and explain how and what needs to be cleaned to ensure a sanitary kitchen. Evaluation will be for completion and a reasonable solution.

[Clean hands = safe hands](#) We all know how to wash our hands properly - or do we. This exercise is intended to show that our initial "normal" hand washing is often inadequate. You will use ground spice like cinnamon and oil to "soil" your hands, and then you will wash them. Sometimes repeatedly until they are clean. Evaluated for completion.

[Food Safety Case Studies](#) This activity, built as a quiz in Canvas, will give you scenarios in which you will need to determine the pathogen that caused the outbreak, the unsanitary conditions that lead to the outbreak and which food might be the culprit. Each question will be graded for accuracy.

[How sweet it is](#) You likely have a favorite sweetener. It might be sugar, or not. You will make 3 glasses of Kool-aid, each with different sweeteners and compare the flavors. Evaluated for completion.

[Who wants to eat an oobleck?](#) An oobleck is the name given to a slurry of corn starch and water. You will make and cook this slurry and investigate the properties that make it useful in foods. Evaluated for completion and thoughtfulness of answers.

[The incredible edible egg](#) Will investigate the properties of the proteins in egg whites, and the emulsification properties of the egg yolk. You will separate an egg and create a soft meringue with the assistance of an acid and without. The second part of the assignment will be to add the yolks in and make mayonnaise. Evaluated for completion and accurate answers to the follow-up questions.

[Smart Cookies](#) Cookies are a pretty straight forward thing to make but changing one ingredient can change the outcome. In this assignment, you will make 2 small batches of cookies, with the variation of one ingredient. Evaluated for completion and accurate answers to the follow-up questions.

[The heat is on](#) Many properties of food impact the rate at which they will heat. This experiment will have you use 3 cans of food and heat them in a water bath while you take the temperatures over time. You will graph this data and make some conclusions based on your results. Evaluation will be for completion and thoughtfulness and accuracy of the follow-up questions.

[Let's get cooking](#) This assignment is the "final" for the class. This will be a process in scientific method - posing the question, "what will be the differences if this product is cooked in different manners?" You will choose the product, and

the cooking methods, develop hypotheses, and draw conclusions from the results. Evaluation will be for completion and thoughtfulness and accuracy of the follow-up questions.

Writing style:

While there is no need to participate in class discussions as if you were writing a research paper, you should remember to write using good grammar, spelling, and punctuation. Informality (including an occasional emoticon) is fine for non-academic topics.

Tone and civility:

Let's maintain a supportive learning community where everyone feels safe and where people can disagree amicably. Remember that sarcasm doesn't always come across online.

Citing your sources:

When we have academic discussions, please cite your sources to back up what you say. (For the textbook or other course materials, list at least the title and page numbers. For online sources, include a link.)

Backing up your work:

Consider composing your academic posts in a word processor, where you can save your work, and then copying into the Carmen discussion.

E-Mail Etiquette:

Professional relationships should be maintained when using e-mail for a class. Below I have included guidelines from Bloomsbury's guide on email etiquette that you should follow when drafting your e-mail. I will not respond to e-mails that I consider inappropriate. I will respond to appropriate emails in a timely manner, do not expect an immediate reply. If you require an immediate response, consider visiting with me in person.

DO

- Include a descriptive statement in the subject line.
- Use proper salutations when beginning an e-mail.
- Be concise in the body of the e-mail, use complete sentences and proper grammar.
- Use an appropriate closure at the end of each e-mail followed by your first and last name.

- If replying to an e-mail, reference the original e-mail and its content.
- Be selective of your choice of words. Emotions are difficult to convey in text and without the benefit of facial expressions your sentiment can be lost in the words you choose to write.

DON'T

- Use all capital letters; this conveys a tone of ANGER.
- Use e-mail as a format to criticize other individuals.
- Ask for your grade via e-mail. Grades will not be discussed by e-mail. If you need to discuss a graded item, make an appointment to do so in my office.
- E-mail to inquire when grades will be posted. We will work toward submitting grades promptly, however, recognize that grading assignments and exams requires considerable time to ensure uniformity and fairness.
- Send an e-mail out of frustration or anger. Learn to save the e-mail as a draft and review at a later time when emotions are not directing the content.

Quizzes and exams: There are no quizzes or exams in this course.

Written assignments portions:

Your written assignments portions should be your own original work. In assignments, you should follow any standard format style like [MLA](#) or [APA](#) style to cite the ideas and words of your research sources. You are encouraged to ask a trusted person to proofread your assignments before you turn them in--but no one else should revise or rewrite your work.

Reusing past work:

In general, you are prohibited in university courses from turning in work from a past class to your current class, even if you modify it. If you want to build on past research or revisit a topic you've explored in previous courses, please discuss the situation with me.

Falsifying research or results:

All research/activities you will conduct in this course is intended to be a learning experience; you should never feel tempted to make your results or your library research look more successful than it was.

Group projects: There are no group projects in this course. However, if you are taking this course with a friend, you are welcome to work together on the activities. You each must submit your own pictures and written work.
